

## HERITAGE & CRAFTS FUNDERS' NETWORK (HCFN)

The Heritage & Crafts Funders' Network has been set up as a result of the dialogue established between funders and beneficiaries at the first Radcliffe Trust Round Table in July 2010 and further discussions at the Radcliffe Trust /Heritage Lottery Fund joint event held on 24 March 2011.

### Who is this for

The network is intended to be inclusive but is aimed primarily at independent trusts and foundations who draw on an endowment or invested funds to provide grants to the Heritage & Crafts sector. Other types of funding bodies are also associated with the network.

### Why do we want to do this

The aim of the network is to improve our practice of grant-giving in the Heritage & Crafts sector and the quality of the support we provide. Participation in the network is solely for these purposes.

### Support

The network meets twice a year. It is coordinated by Carole Milner, Adviser to the Radcliffe Trust, and administered by The Trust Partnership (TTP) on a pro bono basis. As it establishes itself, the HCFN is also benefitting from input from the Association of Charitable Foundations (ACF).
