The significant link between heritage and well-being should be capitalised on, particularly the opportunities to use conservation and craft for engaging marginalised communities and those who are traditionally excluded from the broader heritage sector.

Collaborative working between culture and heritage bodies should be championed and the benefits of skills sharing and nurturing sector-leading professional development celebrated. However, a collaborative approach must not provide a route to reducing head count purely to save costs and lead to the loss of specialist professionals, and specialisms, from the Welsh cultural sector.

The culture sector in Wales is supported by a highly skilled professional workforce with the underpinning knowledge and technical skills to protect and preserve the nation's collections.

Resilience is a key challenge for the conservation sector.

The conservation profession is highly skilled but relies on a relatively small workforce that is essential to ensuring collections can be protected and preserved for future generations. Conservation also provides vital support that underpins the ability to deliver touring and lending from large organisations such as Amgueddfa Cymru to the smaller cultural organisations across Wales – essential in enabling communities to engage with their shared cultural heritage.

However, many vitally important areas of conservation practice exist on a knife edge. Icon's membership represents more than 150 different material specialisms and areas of conservation practice, often carried out by just a handful of individuals. The issue presents a particularly acute challenge in Wales, where there are just 125 Icon members who work across 24 areas of conservation practice. 16 of which are practiced by less than 5 individuals. Any small, losses in the number of practitioners will have a significant impact on the ability to care for collections in Wales.

These issues are compounded in Wales as the reduction in funded, and economically viable, conservation posts, along with the budget to contract services from private practice on a regular basis, leads to the loss of specialist conservation skills and expertise from Wales and has a knock-on impact across the wider UK. The Government must recognise this risk and ensure that work is done to turn the tide and support the development of the conservation profession more broadly.

Further complicating matters, there is a need to provide more effective support to the education sector to ensure a sustainable pipeline of trained conservators coming into the profession. There is currently only one programme in operation in Wales, however the high space and resource requirements will inevitably place such courses at risk when competing with programmes that are more profitable in the short-term.

We commend the overall priorities outlined in the 'Priorities for Culture in Wales, 2024 to 2030' and believe they set a strong foundation for the cultural sector. However, we would like to highlight two critical areas that require further attention:

### 1) Fragility of the Conservation Profession:

The document could more explicitly acknowledge the fragility of the conservation profession in Wales. The current state of this profession poses a significant risk to our collective ability to protect and preserve collections. Without adequate support and resources for conservation professionals, the long-term sustainability and safeguarding of

our cultural heritage are at risk. We strongly recommend that this issue be addressed within the priorities, ensuring that the necessary steps are taken to bolster this essential part of the sector.

### 2) Dependence on Amgueddfa Cymru:

The priorities should also recognize the reliance on Amgueddfa Cymru for supporting smaller museums, galleries, and cultural organizations across Wales. Amgueddfa Cymru plays a crucial role in providing expertise, resources, and guidance to these institutions. Acknowledging and reinforcing this support network within the strategic priorities would ensure that smaller organisations continue to benefit from the invaluable assistance provided by Amgueddfa Cymru.

We believe that addressing these points will strengthen the strategic framework and better position Wales to preserve its rich cultural heritage for future generations.
